The New Hampshire Department of Environmental Services invites you to join, at no cost to you, a growing group of business leaders committed to bringing about a more sustainable New Hampshire—the **Environmental Leadership Initiative**.

ASPIRING LEADERS is the first tier of DES's new, voluntary, non-regulatory initiative that recognizes the many voluntary efforts of businesses and organizations in New Hampshire that improve our environment and economy.

ASPIRING LEADERS' objectives are simple: to encourage individuals, organizations and businesses to do more than the required minimum to improve our environment and economy.

In addition, **ASPIRING LEADERS** will help participants increase their environmental commitment, thus reducing their costs and their overall environmental footprint, and thereby gaining a competitive advantage.

The foundation of **ASPIRING LEADERS** is tracking progress on improvement projects that lead to cost reductions and comprehensive environmental management. Each new member is required to sign a pledge of environmental performance, and to do one or more projects each three-year membership term, depending on the participant's membership level. DES helps members choose projects tailored to each member's circumstances.
