##### **From the South and West**

Take I-93 north to Exit 16. Turn right off exit ramp. Turn right onto Rt. 132 (East Side Drive) and take the immediate right onto Portsmouth St. Follow 0.3 miles past the Conservation Center and up the hill and turn right into the River Council/SPNHF parking lot.

##### **From the North**

Take I-93 south to Exit 16. Turn left off exit ramp and cross overpass. Turn right onto Rt. 132 (East Side Drive) and take the immediate right onto Portsmouth St. Follow 0.3 miles past sharp left turn, by the Conservation Center and up the hill and turn right into the NH River Council/SPNHF parking lot.

##### **From the East**

Take Route 4 west to Concord (Route 4 becomes I-393 in Concord). Take Exit 2 and turn right at end of exit ramp onto East Side Drive. Follow East Side Drive 1 mile and turn left onto Portsmouth St. NH River Council/SPNHF is on the left after 0.3 miles.
